The chair reports the committee's results in writing to the district director no fewer than six weeks before the district's Annual Business Meeting. The district director submits the report in writing to all members of the district council at least four weeks before the Annual Business Meeting. This may be done in the district newsletter or on the district website. At the discretion of the district director, a statement from each nominee outlining their qualifications and abilities to perform the duties of the office may be included with the report. Only candidates nominated by the committee may be included in the report. A district cannot publish the names of floor candidates with the committee report or in any other district publication.

The District Leadership Committee (DLC) Chair hereby certifies that the above listed candidates have passed the DLC evaluation process and interviews and are hereby nominated for the ballot at the District 48 elections to be held at the District 48 Conference on May 2, 2020.

As prescribed by the Toastmasters International Policy, Protocol 9.0:

- For District Director and Program Quality Director, a minimum of one (1) candidate must be nominated herein by DLC to qualify and certify the DLC report for those positions as a "Valid Report".
- For Club Growth Director, a minimum of two (2) candidates must be nominated herein by DLC to qualify and certify the DLC report for Club Growth Director as a "Valid Report"
- For Division Director is considered as one (1) role by Toastmasters International policy, where the number of candidates nominated by DLC is equal to or exceeds number of Divisions within the District, the DLC report is qualified and certified as a "Valid Report" for Division Director position(s), regardless which Division any one of the nominated candidates prefers.
- Where the DLC report is qualified and certified as a "Valid Report" for the particular leadership position, No candidate may run and contest that position from the floor during the District elections, unless the candidate has gone through the DLC evaluation process and interview for that position.
